The Norfolk Field Naturalists organization, established in 1962, is dedicated to the acquisition and extension of knowledge of natural history and the appreciation, enjoyment and stewardship of natural environment, especially within the Counties of Norfolk and Haldimand.

NFN members participate in monthly meetings from September to May. Guest Speakers present programs on interesting and relevant natural history and conservation topics. Field outings are held throughout the year with trips of local interest and significance. Junior naturalists are encouraged to participate with their families. Annual membership is \$20 Individual or \$30 for a Family, \$500 for Life Individual. For 2016 - 2017, the NFN had a total of 215 members in good standing (each family membership counts as 2 members) including 1 Life Member, 5 Supporting Members (dues + donation of at least \$100) and 38 Contributing Members (dues + donation of \$10 - \$99).

NFN has always taken leadership in public education and protection of our local natural treasures. Actions taken include participation in recovery teams for various species at risk, restoration and preservation of habitat, participation in annual bird and butterfly counts and acting in an advisory capacity to local authorities and environmental planning groups.

Club members receive the Lotus, a newsletter with articles on local natural history and club activities. The NFN has taken an active role in protecting local areas of natural significance by participating in planning exercises and helping other groups raise funds for land acquisition.

Directors are chosen / elected from the membership, renewed annually, and normally limited to a period of six years' consecutive service. One Honourary President and one or two Honourary Directors may be appointed by the Board in recognition of long and outstanding service to the NFN; they may be called upon by the Board to act in an advisory capacity.

President's Report 2016 - 2017

Dear Members of the Norfolk Field Naturalists,

Another eventful season of the NFN has passed during which we have continued with a great array of field outings and indoor presentations by interesting guest speakers.

The Board of Directors undertook a major task this year. Our constitution and bylaws needed to be updated, as the last version was enacted in 1996 - 21 years ago. We had already been waiting

for the provincial template for a couple of years, but the Ontario legislature have obviously had more urgent items on their agenda. We decided to proceed with the federal version of Not-for-Profit Organizations, such as the NFN. Eventually, when a provincial template becomes available we'll review the bylaws and make any necessary amendments at that time. This is very similar to the Building Code, which I had to get quite familiar with in my previous life in the construction design industry. The provinces take the national code and modify it to suit conditions in their area.

The Board formed a small Bylaw Review Committee consisting of Bernie Solymár, Jan Grincevicius and myself. Jan has extensive experience and expertise in this subject and has been instrumental in finalizing our new Bylaws, Schedules, Policies and Procedures, which we enacted at the Annual General Meeting on September 12, 2017. Reviewing, discussing, editing, correcting and finalizing these documents has been months in the making. Thank you all for the input we received.

The NFN is still supporting other organisations by donating funds and manpower. We are proud to be able to help LPBLT in their quest to acquire new important land tracts in our area. We assisted with a controlled burn at the St. Williams Forest Reserve and the road-side clean-up at the NCC's Backus Block properties. The silent auction at our Movie Night in May brought some funds for NCEE and our collaboration with Long Point Phragmites Action Alliance supports their fight against this invasive plant.

This year, sadly, we have lost a few long-time members who have over the years contributed greatly to our organisation. Among the most notable are Harry B. Barrett, Jim Harlow, Ruth Loughton and Pat Robinson. Our sincere condolences go out to their families.

The Board of Directors has also had a few changes: David Curry, who was looking after publicity for NFN and our secretary, Eleanor Chithalen, have both tendered their resignations after years of service. Cliff Skerratt also stepped down from the Board of Directors. We welcome a new Director-at- Large, Cindy Presant, who accepted the nomination at the Annual General Meeting. Jan Grincevicius agreed to take over from me as the new Lotus Editor. Her first edition is expected in October. This has been a fun, creative and rewarding project that I have enjoyed for the past 5 years and I will still contribute to the newsletter from time to time.

Lastly, I'd like to extend my sincere gratitude to all Members of the Board for their services this year.
